# Request from the Office of Healthcare Professionals Recruitment

The Office of Healthcare Professionals Recruitment intends to conduct a survey of psychologists to understand the factors that shape their decisions on whether to work in the private and/or public sectors. To help inform the design of this survey, they would first

### **Telepsychology**

Nova Scotia and New Brunswick

In the context of telepsychology, NSBEP & CPNB interpret "practice" as occurring in the jurisdiction where the psychologist is registered. Accordingly, psychologists registered and licenced to practice by a regulatory authority elsewhere in Canada may deliver telepsychology services to clients in Nova Scotia & New Brunswick without having to obtain additional registration. For clarity, when providing in-person psychology services in Nova Scotia, psychologists registered and licenced in other jurisdictions must first obtain registration with NSBEP. For the temporary provision of in-person services, NSBEP has a Courtesy Register available.

Atlantic MOU on Telepsychology

The provincial regulators in PEI and NL have decided to update their approach with telepsychology to require temporary registration/authorization from their respective jurisdictions. As a result, the Atlantic MOU on Telepsychology is no longer in effect.

Starting at the beginning of 2024, NSBEP has been required to complete the specific forms that are now required by regulators in PEI and NL to enable registrants who are practicing telepsychology with clients there to continue to do so. NSBEP is required to charge a \$40 fee to cover the work and costs associated with completing the specific form required by each jurisdiction in a timely manner.

These changes in PEI and NL are outside the control of NSBEP. If psychologists have any concerns about these changes, they are free to contact the regulatory authority in the province.

For NSBEP Registrants wanting to provide Telepsychology Outside of NS & NB

If a NSBEP registrant intends to provide telepsychology services to a client outside of Nova Scotia or New Brunswick, the registrant should first contact the regulatory authority of the jurisdiction to determine what applicable requirements may be in place. The Board expects that registrants will investigate and respect the requirements of other jurisdictions when providing telepsychology or in-person services in other jurisdictions.

Most other jurisdictions may require at least some form of temporary registration in their jurisdiction. You are required to check with the jurisdiction to see what is required to see a client(s) who may located in their jurisdiction (or if you will be located in their jurisdiction when providing telepsychology services).
