### **ORAL EXAMINATIONS**

Further to a prior Email Update in March 2022, the Board has been developing a pool of ethical dilemmas for use in oral exams. The process was amended and became effective in July 2022. With the change, candidates are now provided with an ethical dilemma/scenario by the Committee during the exam.

# NOVA SCOTIA GOVERMENT CHANGE TO GENDER AFFIRMING SURGERY APPLICATION REQUIRMENTS

The Department of Health and Wellness has requested that the following information be distributed to registrants.

Please note that this governmental change in requirements does not alter the need for a regulated professional to follow their own professional standards for practicing within their areas of competence. As is the case with any aspect of practice, psychologists must have

the necessary training, skills and experience to carry out any particular activities.

Effective July 20, gender affirming surgery applications no longer require a letter of support from a Nova Scotia specialist and a letter from a specialist confirming post-operative care if the surgery was happening in Nova Scotia. A letter from a physician or nurse practitioner confirming post-operative care is still required if the surgery is happening outside Nova Scotia.

A psychosocial assessment letter is still required. Physicians, nurse practitioners and specialists who have specific skills in gender-affirming care can now complete the assessment, provide the letter and sign the application.

You can also access a Confirmation of Registration document that you can save to your computer and/or print off if you wish to share it with others to verify your registration, e.g., an employer, insurance companies, agencies, etc. This document confirms that a psychologist's registration has been renewed and states the current year of registration.

You can return to this portal at any time in future, if you wish to obtain another

Confirmation of Registration, update your contact information or psychological practice profile, or even pay a miscellaneous fee (e.g., paying an oral exam fee, reinstatement fee, etc.).
