NSBEP Email Update

COVID VACCINATIONS

NSBEP is aware that there can be differences in the degree of exposure to COVID-19 being faced by psychologists. We have written to our contacts in the Department of Health and Wellness (DHW) regarding these types of situations and the impact they can have on the provision of mental health services. The response was that the information would be passed on to those who have input into decision making. So far, psychologists are not being treated any differently than the majority of the other 24 regulated health professions in Nova Scotia. As you are likely aware, the government approach has been to prioritize ages, employment situations and professions which, as groups, are most likely to be at risk.

Individual psychologists are free to seek out vaccination at any time if they qualify because of age or other prioritization identified by the government; they do not need to wait until psychologists and other health professions are invited based on professional demographic.
